The above sanction is subject to fulfilment of the following conditions:-

1. Untrained teacher be replaced by the suitable Qualified teacher under intimation to this office their particulars on the prescribed proforma (copy enclosed).
2. Qualified/suitable Librarian be appointed.
3. Five hundred more books be added in the school library.
4. Provision be made for old/age benefits for the teaching and non-teaching staff of the school.
5. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for All India Sec. and changes made therein from time to time.
6. The school shall appoint only qualified and eligible staff.
7. Service agreement shall be executed. Services of any employee of the school shall not be terminated without the prior approval of the Board.
8. Service conditions, Pay and Allowances and other benefits to the employees of the school shall in no way be less than corresponding employees working in Government schools of the State.
9. The school and its records shall be open for inspection by an official of the Board at any time and the school shall furnish informations as may be asked for by the Board from time to time.
10. The school shall not run on profit basis nor for accruing any advantage to a person or group of persons.
11. The school premises or the property shall not be used for commercial or residential purposes (except where staff quarters are there) or for communal, political or non-educational activities of any kind whatsoever.
12. The rate of tuition and other fees shall not be changed without the prior permission of the competent authority.

13. The admission to the school shall be open to all without any discrimination on the ground of religion caste or race, place of birth or any of them.

14. No unrecognised classes shall be run within the Premises of the school.

15. The school will help the Board in the smooth conduct of the examinations by placing the necessary accommodation i.e. Halls, Rooms available in the school premises and furniture at its disposal for holding its examinations free of charge, if required, to do so.

16. The school will spare sufficient teachers for invigilation purposes at the examinations of the Board as may be required by the Board.

The school shall follow the instructions laid down by the Board from time to time and abide by all the rules and regulations of the Board (copy enclosed) and remit annual fee of Rs. 100/- regularly as per one of the rules. 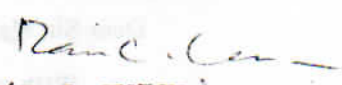
